## **General Building Information Sheet**

### **Building Certification and Building Approvals**

- The legislation controlling building work in Queensland includes the *Planning Act*, the *Building Act*, the *Building Regulation*, the *Building Code of Australia* and the *Queensland Development Code*. This includes applications for most forms of development including building work.
- You have a choice of using your Council or a private certifier. If a private building certifier is engaged, a notice of engagement must be sent to the Murweh Shire Council. When the building approval is issued by the private certifier they must forward a copy of the approval documents to Council.

Building applications are necessary for these types of building activities:

- New dwellings or commercial buildings
- Alterations or additions to existing buildings
- Restumping
- Building removal and relocation
- Demolitions
- Carports and sheds 10m<sup>2</sup> or larger
- Gazebos, pergolas and shade sails over 10 square meters
- Fences over 2 meters in height above the natural ground level
- Retaining walls over 1 meter in height, or within 1.5m of a building or other retaining wall
- Swimming pools and spas

#### **Plumbing and Drainage**

- A plumbing application is required to be submitted to Council for any plumbing and drainage carried out to domestic and/or commercial properties. Plumbing and drainage, amongst other things, can consist of new or additional plumbing fixtures (toilets, basins, showers).
- Plumbing applications are made on Form 1 under the Plumbing and Drainage Act.

#### **QBCC Insurance**

- The Queensland Building and Construction Commission (QBCC) provides a homeowner's protection scheme on domestic construction work. Registered builders and licensed contractors must pay insurance when the value of residential works exceeds \$3,300.
- Evidence of cover by the registered contractor should accompany the application.
- QBCC insurance is not payable on building work where an owner builder number has been obtained or on commercial work.

#### **QLEAVE**

 For works costing \$150,000 or more, the QLEAVE (Portable Long Service Leave Scheme Levy) form and receipt of payment must be sighted by building certifiers prior to approval and should accompany the application.

#### **Lodging an Application**

When submitting a building application the application must consist of the following:

- DA Form 2
- Plans (including site plan, floor plan and elevations)
- Application fee
